Your library membership begins with a **Discover** card. The Discover card will allow you to borrow three physical items at a time, access digital collections, register for programs, and use the Internet for one year.

To upgrade to an **Explore** card and increase your borrowing privileges for a two-year period, bring a piece of photo identification and proof of to your closest library branch.
